ENGINEER'S REPORT
GLOUCESTER TOWNSHIP M.U.A.

May 10, 2017

- The Xylem technician continues to provide weekly effort to complete the pumping station control and monitoring upgrades at the retrofit stations. Xylem has provided a tentative schedule for delivery of new panels in June. The progress inspection by the NJDEP was successfully completed on April 20th.
- Warshauer Generator, LLC is scheduled to complete the first portion of the 2017 generator preventative maintenance services by the end of May. My office will review work tickets and application for payment upon completion of this segment.
- 3. My office is working with the Authority to obtain pricing for rehabilitation of structures at the Stephen Drive and Fay Ann Pumping Stations.
- 4. My office is working with the Authority and Atlantic City Electric (ACE) on the electrical service upgrade at the Wye Oaks Pumping Station. Electrical plans have been prepared for the improvements and an application to ACE has been submitted for review. We are awaiting final contractor quotes before scheduling the work.
- 5. The bid documents for the 2017 procurement of Xylem Pumps, Spare Parts and Accessories are being advertised for a bid opening in June.
- The bid documents for the 2017 Emergency Repairs to Wastewater Conveyance System, Mains and Laterals and Supplementary Construction Services are being advertised for a bid opening in June.
