ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

September 14, 2017

- 1. Xylem technicians have installed all new pumping station control panels and communications packages except for those at Highland Village and LaCascata. Xylem is coordinating the remaining work at Highland Village and LaCascata with the Authority. Xylem has submitted a contract extension request that has been reviewed and recommended for approval under separate cover to complete the remaining work. Xylem has also submitted request for payment that has been recommended under separate cover.
- 2. The Authority received the electrical permit from the Township Construction Office for the Wye Oaks panel upgrades. The work is scheduled to be completed the week of September 18th.
- Evoqua Water Technologies has submitted a request for extension of the current odor control contract with the Authority. The extension would allow the Authority to utilize the same unit costs as per the 2016 contract. A recommendation has been submitted under separate cover.
- 4. My office assisted the Authority and Recycling Coordinator with the preparation and submission of the Recycling Center permit renewal request. The current permit is scheduled to expire on December 17, 2017.
- 5. On August 31st, a site meeting was conducted at the Hidden Mill Pumping Station to review the list of items to be addressed prior to dedication. The meeting was attended by the station owner, the Authority and Xylem to compile the list of outstanding issues to be corrected for the Authority to take responsibility for the station.
