#### December 16, 2021

- On November 22<sup>nd</sup>, the Authority received a sewer service inquiry for potential connection near Love Drive and Commencement Drive. My office reviewed with the Authority and provided information for submission of a feasibility request.
- 2. On December 3<sup>rd</sup>, the Authority received a sewer service inquiry for potential utility conflicts at the intersection of the Black Horse Pike and Station Avenue. NJDOT is proposing signal improvements at the intersection and have identified potential underground conflicts. My office is reviewing with the Authority to provide a response to the NJDOT design engineer regarding existing sewer at that location.
- Plans and specifications for the installation of an emergency generator at the Brookwood Pumping Station have been completed. A set of plans and specs have been transmitted to the Authority for review. The bids are being advertised and tentatively scheduled to be opened prior to the January meeting.
- 4. On November 4<sup>th</sup>, a request was received regarding the release of the maintenance guarantee for the constructed improvements at the Royal Farms in Winslow Township. The improvements have been completed and inspected. A recommendation letter for the release of the maintenance guarantee has been submitted under separate cover.
- On November 12<sup>th</sup>, a request was received regarding the release of the performance/maintenance guarantee for the constructed improvements at the Union Square Development on Jarvis Road. The improvements have been completed and inspected. A recommendation letter for the release of the performance/maintenance guarantee has been submitted under separate cover.
