# ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

#### November 21, 2019

- Contract documents have been transmitted to Penn Power Group for execution for the Stephen Drive Pump Station Emergency Generator replacement project.
- 2. The Authority has received the TWA for the Orr Road sewer upgrades. A preconstruction meeting was conducted on November 12<sup>th</sup> with R.D Zeuli, Inc. and the Gloucester Township Traffic Services Bureau to review schedule and traffic control. The work is tentatively scheduled to begin on December 2<sup>nd</sup>.
- 3. On October 15<sup>th</sup>, the Authority held a meeting with Xylem to review outstanding issues with the pumping station monitoring and controls system. The Authority is providing regular updates and feedback in the continuing issues. Xylem is scheduling a follow up visit the week of December 2<sup>nd</sup>.
