# ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

## November 9, 2017

- Xylem technicians have completed installation of the controls and monitoring hardware at the Authority's pumping stations. The first training session on the PumpView software was completed at the Authority's office during the week of October 30<sup>th</sup>. Technicians are currently addressing punch list items and working toward closeout of the project.
- 2. Xylem conducted the pump inspection at the Hidden Mill Station on November 1<sup>st</sup>. The Authority was present for the inspection and recorded their observations of the pump evaluation. My office and the Authority will review the official reports and provide our feedback to the recommendations provided by Xylem.
- 3. The Contractor has scheduled Atlantic City Electric and Xylem for final service connection and programming and startup of the Wye Oaks power and control panels. The work is scheduled to be completed during the week of November 13<sup>th</sup>. A recommendation for partial payment has been provided under separate cover.
- 4. Draft plans and specifications for the generator replacements at Twin Streams and Front & Woodland Pumping Stations have been submitted to the Authority for review. The project is tentatively scheduled for advertisement the week of November 13<sup>th</sup>.
- 5. On October 24<sup>th</sup>, the Authority received the Notice of Administrative Completeness for the Recycling Center General Approval Renewal.
- 6. The following applications have been reviewed and recommended for approval:
