ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

- The generators at the Raintree Pumping Station and Administration Building have been installed, tested and placed into service. My office has reviewed the final payment application and recommend payment in the amount of \$4,530.03 to Maguire Electrical for the services provided.
- National Water Main Cleaning Company is in the process of completing lining activities along Millbridge Road. The lining along Church Street will begin after the completion of Millbridge.
- 3. The Atlantic City Electric (ACE) transformer pad for the Cherrywood Pumping Station has been formed and being prepared to be poured. My office is coordinating with the Authority and ACE to complete the pad for inspection prior to scheduling the electrical upgrade work. My office has prepared plans and specifications for the electrical work on the Authority side and has solicited quotes from several local electrical contractors.
- 4. My office has revised the design to the Orr Road sanitary sewer improvements to incorporate review comments by the Authority. My office is finalizing the design plans and Treatment Works Approval documents for submission to NJDEP.
- 5. The technical specifications for the heavy-duty service truck have been revised in accordance with Authority comments. My office has contacted the manufacturer for updated specification information.
- My office has prepared the bid documents for the annual Hydrogen Sulfide Control Services and respectfully request authorization to advertise.
