ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

September 20, 2018

- The preconstruction meeting was held on August 10th with Insituform for the pipe line rehabilitation work. Shop drawings have been submitted and reviewed. The cleaning and televising of the lines commenced on September 13th. The slip lining work is tentatively scheduled for the end of September.
- 2. The tentative delivery date for the Raintree Pumping Station and the Administration Building generators is October 31st. My office and the MUA will work with the Contractor to complete the necessary site preparation work prior to the delivery of the generators.
- 3. My office is in contact with Atlantic City Electric weekly to obtain project status and schedule for the proposed service upgrade work at the Cherrywood Pumping Station.
- Field survey along Orr Road and at the Glen Oaks pumping station has been completed and preliminary plan information is being reviewed for proposed upgrades at those locations.
- On August 17th, a meeting was held with Evoqua representatives to review chemical usage and potential chemical changes to improve system performance. On August 22nd, a letter was received from Evoqua Water Technologies requesting an extension of the contract for Hydrogen Sulfide Control Services at the current terms and conditions for review and approval by the Authority.
