# ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

#### April 19, 2018

- The Authority has submitted the request for final NJEIT loan reimbursement. NJDEP is in the process of approving the application. A final inspection is being scheduled with the NJDEP to review project closeout.
- Final design details of the generators for the Raintree Pumping Station and the Administration Building have been reviewed and approved by the Authority. The bid documents have been assembled and we respectfully request authorization to advertise.
- The generator for the Twin Streams Pumping Station is scheduled for delivery on April 16<sup>th</sup>. The generator for the Woodland Pumping Station is scheduled for delivery on April 23<sup>rd</sup>.
- 4. My office has prepared the bid documents for the 2018 procurement of Xylem Pumps, Spare Parts and Accessories and respectfully request authorization to advertise.
- My office has prepared the bid documents for the 2018 Emergency Repairs to Wastewater Conveyance System, Mains and Laterals and Supplementary Construction Services and respectfully request authorization to advertise.
- Proposals for the Authority's Emergency Generator Maintenance and Inspection Services were opened on April 10<sup>th</sup>. A recommendation to award has been provided under separate cover.
- 7. On March 12<sup>th</sup>, a gravity main issue was reported along Millbridge Road. A section of the 16" terracotta main at approximately 6 feet deep was broken. R.D. Zeuli, Inc. completed the emergency repairs and placed the main back into service. I have recommended payment in the amount of \$29,382.69 to R.D. Zeuli, Inc. for the services provided.
- 8. On March 27<sup>th</sup>, a lateral issue was reported at 141 W. Church Street. A section of the terracotta lateral at approximately 10 feet deep was broken. R.D. Zeuli, Inc. completed the emergency repairs and placed the lateral back into service. I have recommended payment in the amount of \$7,222.50 to R.D. Zeuli, Inc. for the services provided
- 9. On March 29<sup>th</sup>, the Authority received the Class C Recycling Center General Approval Permit Renewal. The permit's expiration is March 29, 2023.
