# ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

# February 8, 2018

- The Authority and my office attended a progress meeting with Xylem on January 30<sup>th</sup> to review the status of the monitoring and control services. Xylem is scheduled to provide the spare parts and as-built drawings for project close out by the end of February. Xylem is providing the necessary information to allow the Authority to host the system's controls internally to minimize the recent service interruptions.
- The decommissioned wiring and conduit have been removed and the site restoration work at the Wye Oaks Pumping Station has been completed. My office will work with the Contractor on submission of the necessary close out documents.
- The shop drawings for the generator replacements at Twin Streams and Front & Woodland Pumping Stations have been reviewed and returned to the Contractor for procurement.
- My office is assembling the bid documents for the Authority's annual emergency generator maintenance and inspection services for 2018-2019 and respectfully request authorization to advertise.
- 5. On January 17<sup>th</sup>, a lateral issue was reported at 35 Hollyoke Road in the Timber-Line section of the Township. A section of the orangeburg pipe at approximately 7 feet deep was broken. R.D. Zeuli, Inc. completed the emergency repairs and placed the lateral back into service. I have recommended payment in the amount of \$5,600.10 to R.D. Zeuli, Inc. for the services provided.
