# ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

## September 15, 2022

- The improvements for the Orr Road Phase II project have been completed. My office has completed and returned the Certification of Completion form to the NJDEP to close out the treatment works approval permit. I have recommended payment in the amount of \$170,388.26 to R.D. Zeuli, Inc. for the services provided.
- 2. Wysocki Electric, Inc. has completed the emergency electrical repairs at the Authority power panel. Wysocki is coordinating with PSE&G to schedule the installation of the new electric meter to re-energize the panel.
- My office has obtained the preliminary flow data for the Sicklerville Road flow study. Due
  to the prolonged dry weather, my office has extended the project schedule for a minimum
  of another 30 days to incorporate additional wet weather flows.
- 4. On September 20<sup>th</sup>, my office along with Authority representatives will attend the preconstruction meeting for the replacement of the Somerdale Road Bridge hosted by the Camden County Engineering Department. The Authority will review schedule and impacts to the Authority's facilities as a result of the County project.
