ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

October 20, 2022

- On September 14th, a sewer main issue was reported near the intersection of Front Street and Woodland Avenue. Pioneer Pipe Contractors, Inc. while installing other utilities in the area reported the sewer main break to the Authority. At the direction of the Authority, Pioneer completed the emergency repairs by replacing a section of 12-inch gravity main at approximately 7-1/2 feet deep. I have recommended payment in the amount of \$20,912.33 to Pioneer Pipe Contractors, Inc. for the services provided.
- 2. On September 20th, the preconstruction meeting for the Somerdale Road Bridge replacement project was held at the Camden County offices. The construction activities will not impact the Authority until the Phase II portion of the project tentatively scheduled for the first quarter of 2023. My office will work with the County's design engineer to coordinate construction as it affects the Somerdale Road Pumping Station.
- On September 23rd, the Contractor for the NJDOT bridge replacement project over Route 42 successfully conducted air testing of the replacement GTMUA and CCMUA force mains. NJDOT is continuing to bypass sewer flows around the new bridge until completion of the project.
- On September 27th, a letter of credit reduction request was received for The Reserves at Independence Square – Phase 3. A recommendation letter has been submitted under separate cover.
- 5. On October 4th, bids were opened for the Hydrogen Sulfide Control Services contract for 2022. A recommendation to award has been submitted under separate cover.
- 6. Record as-builts of the improvements for the Orr Road Phase II gravity sewer main replacement project have been submitted to the Authority for review and approval.
- My office has received the remainder of the survey information for the existing Orr Road
 Force Main, and we are preparing preliminary design plans for the force main
 replacement.
- 8. The flow meters for the Sicklerville Road flow study were removed on October 6th. My office will review and analyze the flow data with the Authority.
- 9. The following application has been reviewed and recommended for approval:
 - Contingent Form D Jarvis Road Major Subdivision, 1271 Jarvis Road (aka Block 16504, Lots 10, 11 & 12)
