# ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

## January 20, 2022

- The plans and specifications for the new Brookwood Pumping Station Emergency Generator have been advertised for bid on January 18<sup>th</sup>. The bid proposals are scheduled to open on February 8<sup>th</sup>.
- 2. On December 8<sup>th</sup>, a force main issue was reported at Landing Road and Lower Landing Road near the Authority Administration Building. A section of the 8" force main from the Pine Run Pumping Station was damaged during the installation of a new gas main. R.D. Zeuli, Inc. completed the emergency repairs by installing a new section of replacement PVC force main. I have recommended payment in the amount of \$10,615.59 to R.D. Zeuli, Inc. for the services provided.
- 3. On December 31<sup>st</sup>, an issue was reported at the Highland Park Pumping Station located at the Jamestown Square Apartments. A section of the 4" bypass piping was damaged due to a single vehicle collision at the station. R.D. Zeuli, Inc. completed the emergency repairs to the bypass piping to prevent sanitary sewer overflow. I have recommended payment in the amount of \$3,943.78 to R.D. Zeuli, Inc. for the services provided.
- 4. On January 12<sup>th</sup>, the Orr Road Phase II Treatment Works Approval application package was transmitted to the NJDEP for review and approval. The proposed work includes the installation of new gravity piping as a direct replacement of existing collection system piping to improve the hydraulics and stabilize flows into the head works of the Orr Road Pumping Station.
- 5. On January 21<sup>st</sup>, work is scheduled at the Lincoln Avenue Pumping Station to replace the existing junction box and control wiring due to deterioration. The installation will address operational issues experienced with the pumps at the station.
- 6. The following application has been reviewed and recommended for approval:
  - Contingent Form F Modwash Car Wash, 810 New Brooklyn-Erial Road (aka Block 18103, Lot 7.01)
